2. Announcement of decision on the proposal by the Town of Greece to amend the Code of the Town of Greece, New York, Chapter 211 (the Zoning Ordinance).
3. Issuance of a Negative Declaration for the coordinated environmental review of the Town’s Upper Round Pond Watershed project, which indicates a finding of no significant adverse environmental impact.
