**NOTICE IS HEREBY GIVEN** that the Proposed 2022 Budget of the Barnard Fire District in the Town of Greece, State of New York, will be presented to the Board of Fire Commissioners of the Barnard Fire District, for its consideration.

A PUBLIC HEARING will be held at 6:00 p.m. at Barnard Fire District, 3084 Dewey Avenue, Rochester, New York 14616, in the Town of Greece, County of Monroe, State of New York, on the 19<sup>th</sup> day of October 2021.

Fursuant to Town Law §105, the Board of Fire Commissioners must hold a public hearing on the budget, make the proposed budget available to the public prior to the public hearing, and allow the public to comment on the budget at the public hearing. This public hearing must be held to allow maximum public participation in the hearing.
