

LEGAL NOTICE OF PUBLIC HEARING UPON ANNUAL
ESTIMATES AND ASSESSMENT ROLLS FOR
SPECIAL IMPROVEMENT DISTRICTS

PLEASE TAKE NOTICE that the Town Board of the Town of Greece, Monroe County, New York, acting on behalf of certain improvement districts, has prepared, completed and filed in the office of the Town Clerk, One Vince Tofany Boulevard in said town, where they are available for inspection by any interested person at all reasonable hours, the annual estimates and assessment rolls for the various special improvement districts for the fiscal year commencing **January 1, 2018** as follows:

For the payment of principal and interest on bonded indebtedness and for the expense and maintenance and operation of sewers and treatment plants of Sanitary Sewer District No. 1, and Extension Nos. 3, 4, 5, 6, 7, 8, 9, 375, 376, 402, 405, 436, 448, 449, 458, 463, 469, 475, 493, 494, 516, 527, 528, and 532-7 thereof, intending to include all the property within said district boundaries as follows:

Beginning at a point, said point being on the shores of Lake Ontario at the intersection of the northwest corner of the Town of Greece and the northeast corner of the Town of Parma;

Thence, (1) southerly along the west boundary line of the Town of Greece, said line being the east boundary line of the Towns of Parma and Ogden, for a distance of 56,072 feet, more or less, to a point, said point being the southwest corner of the Town of Greece and the northwest corner of the Town of Gates; thence, (2) easterly along the south boundary line of the Town of Greece, and part of a boundary of the City of Rochester for a distance of 24,104 feet, more or less, to a point, said point being the intersection of the southeast corner of the Town of Greece and an angle point in the westerly boundary of the City of Rochester; thence, (3) generally north along the various courses comprising the easterly boundary of the Town of Greece and the westerly boundary of the City of Rochester, for a distance of 43,920 feet, more or less, as measured along the various courses comprising the last mentioned boundaries to a point on the shore of Lake Ontario, said point being the northeast corner of the Town of Greece and the northwest corner of the City of Rochester; then, thence (4) northwesterly along the various courses along the shoreline of Lake Ontario which courses form the northerly boundary of the Town of Greece, a distance of 48,800 feet, more or less, as measured along said courses, to the point and place of beginning; being intended to describe the entire area within the boundaries of the Town of Greece.

The boundaries described above are intended to include the remaining portions of Town not currently within any sewer district boundaries.

For the payment of principal and interest on bonded indebtedness and for the operation and maintenance expense of Sanitary Sewer District No. 2, Extension No. 4, and Sanitary Sewer District No. 4, and Elmgrove Road; and

For the payment of principal and interest on bonded indebtedness of maintenance of Drainage District No. 24; and extensions 5, 9, 12, 13, 14, 15; and

For the expense of maintenance of Consolidated Lighting District No. 11; and for the Water District Main Extension, Hogan Point Road.

The estimates and assessment rolls of the following fire districts: Barnard; Greece Ridge; Lake Shore; North Greece; and Hilton-Parma.

FURTHER NOTICE IS HEREBY GIVEN that the Town Board of the Town of Greece will meet at the Greece Town Hall, One Vince Tofany Boulevard in said town, at **5:30 p.m.**, prevailing time, on **Wednesday, November 8, 2017**, for the purpose of hearing and considering any objections which may be made to said estimates and assessment rolls.
