

Minutes of the Regular Meeting of the Town Board, Town of Greece, Monroe County held December 16, 2021 at the Town Hall, One Vince Tofany Boulevard, Rochester, New York at 6:00 p.m.

Due to the Novel Coronavirus (COVID-19) and Delta variant, Governor Hochul has ordered that the requirements of the Open Meetings Law be modified as they were pursuant to Executive Order 220.1. As such, the Greece Town Board meeting of December 16, 2021 was held electronically via Facebook Live instead of a meeting open for the public to attend in person. Members of the public were able to view the Board meeting by logging onto Facebook and viewing the live feed under "Bill Reilich Greece Town Supervisor."

Supervisor Reilich called the meeting to order at 6:11 p.m.

PLEDGE OF ALLEGIANCE:

Supervisor Reilich called upon Councilman Mike Bloomer to lead the Town Board in the Pledge of Allegiance. Supervisor Reilich held a Moment of Silent Prayer and Reflection.

PUBLIC HEARING:

6:00 p.m. – Public hearing to consider the adoption of a proposed local law to opt-out of allowing cannabis retail dispensaries and on-site consumption sites in the Town of Greece as authorized under New York State Cannabis Law Article 4.

Supervisor Reilich declared open the public hearing at 6:13 p.m. The Clerk stated that publication of the notice in the Daily Record on Wednesday, December 1, 2021 to consider the adoption of a proposed local law to opt-out of allowing cannabis retail dispensaries and on-site consumption sites was received. The Clerk further stated that the Legal Notice directed residents to provide comments in writing until 5:00 p.m. the day of the meeting. There were a total of eight comments received from the residents - seven of which were opposed and wanted the members to Opt-Out - one of which was in favor of the retail dispensaries only and not the consumption lounges. These comments were provided to the Town Board for their review in advance of the meeting.

**Local Law #2 of the year 2021
Marihuana Regulation and Taxation Act, Opt-Out**

WHEREAS, the Town Board has considered proposed Local Law #2 of the year 2021 amending Part II, General Legislation, of the code of the Town of Greece and establishing Chapter 134, Marihuana Regulation and Taxation Act, Opt-Out, to opt-out of allowing cannabis retail dispensaries and on-site consumption sites as authorized under New York State Cannabis Law Article 4, and it being considered to be in the best interest of the Town to adopt this proposed local law;

NOW, THEREFORE, be it

RESOLVED, that pursuant to the provisions of the Municipal Home Rule Law and Town Law, the Town Board of the Town of Greece does hereby adopt Local Law #2 of the year 2021 amending Part II, General Legislation, of the code of the Town of Greece and establishing Chapter 134, Marihuana Regulation and Taxation Act, Opt-Out, to opt-out of allowing cannabis retail dispensaries and on-site consumption sites as authorized under New York State Cannabis Law Article 4. Part II, General Legislation, of the code of the Town of Greece is hereby amended and Chapter 134, Marihuana Regulation and Taxation Act, Opt-Out, is hereby established as follows:

Chapter 134 Marihuana Regulation and Taxation Act, Opt-Out

§ 134-1 Legislative Intent.

It is the intent of this local law to opt-out of allowing cannabis retail dispensaries and on-site cannabis consumption sites in the Town of Greece that would otherwise be allowed under New York State Cannabis Law Article 4.

§ 134-2 Authority.

This local law is adopted pursuant to New York State Cannabis Law § 131 which expressly authorizes the Town Board to adopt a local law requesting the Cannabis Control Board to prohibit the establishment of cannabis retail dispensary licenses and/or on-site consumption licenses within the jurisdiction of the town and is subject to a permissive referendum, the procedure of which is governed by Municipal Home Rule Law § 24.

§ 134-3 Local Opt-Out.

The Town Board of the Town of Greece hereby opts-out of allowing cannabis retail dispensaries and on-site consumption sites from being established and operated within the Town's jurisdiction.

§ 134-4 Severability.

If any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgement or order shall be rendered.

§ 134-5 Permissive Referendum/Referendum on Petition.

This local law is subject to a referendum on petition in accordance with New York State Cannabis Law § 131 and the procedure outlined in Municipal Home Rule Law § 24.

§ 134-6 Effective Date.

This local law shall take effect immediately upon filing with the Secretary of State.
