WHEREAS, on the 14th day of September, 2021, pursuant to Section 105 of the Town Law and Section 181 of the Town Law, the Board of Fire Commissioners of the North Greece Fire District confirmed that the Annual Fire District Budget Hearing will be conducted with reference to the Annual Fire District Budget for the fiscal year 2022 on Tuesday, October 19, 2021 commencing at 6:00 P.M. at the North Greece Fire District's Station 2 located at 1766 Latta Road, Rochester, New York, and

WHEREAS, the Board of Fire Commissioners is required to adopt a proposed budget at least 21 days before October 19, 2021 so that it is available for public inspection prior to the budget hearing.

NOW THEREFORE, BE IT RESOLVED that the Board of Fire Commissioners of the North Greece Fire District has adopted a proposed Annual Fire District Budget for 2022 as of September 14th, for purposes of discussion and review at the Budget Hearing to be held on October 19, 2021 and a copy of the proposed budget is available at the office of the Town Clerk of the Towns of Greece and Parma and on the district website at www.northgreecefd.com and at the office of the North Greece Fire District Secretary at 1766 Latta Road, Rochester, New York, where it may be inspected by any interested person during the office hours of 9 AM to 3 PM. In addition, copies of the proposed budget will be available on the night of the said hearing.

NOW, THEREFORE BE IT FURTHER RESOLVED that the Board of Fire Commissioners of the North Greece Fire District will hold the Annual Fire District Budget Hearing to be conducted with reference to the Annual Fire District Budget for fiscal year 2022 on Tuesday October 19, 2021, commencing at 6:00 P.M. at the North Greece Fire District's Station 2 located at 1766 Latta Road, Rochester, New York. The Fire District will require the wearing of facial masks to ensure the safety of everyone in attendance.
