### PUBLIC HEARING

WHEREAS, on the 18th day of September, 2023, pursuant to Section 105 of the Town Law and Section 181 of the Town Law, the Board of Fire Commissioners of the Ridge Road Fire District confirmed that the Annual Fire District Budget Hearing will be conducted with reference to the Annual Fire District Budget for the fiscal year 2024 on Tuesday, October 17th, 2023 commencing at 6:00 P.M. at the Ridge Road Fire District's Headquarters Building located at 1299 Long Pond Road, Rochester, New York, and

WHEREAS, the Board of Fire Commissioners is required to adopt a proposed budget at least 21 days before October 17th, 2023 so that it is available for public inspection prior to the budget hearing.
