- 1. Authorization to make various adjustments and transfers to the 2022 budget (list attached).
- 2. Authorization to enter into various agreements for programs associated with the operation of the Greece Community and Senior Center.
- 3. Authorization to enter into a professional services agreement with EAP Workforce Solutions to provide EAP services to the Town's workforce. This is a renewal contract. Authorization for the Supervisor to execute all necessary documents.
- 4. Authorization to appoint one full time Laborer effective September 17, 2022.
- 5. Authorization to abolish one full time Acting Technical Services Coordinator and appoint one full time Technical Services Coordinator, effective September 17, 2022.
- 6. Authorization to appoint two full time Road Patrol Officers effective September 17, 2022.
- 7. Authorization to appoint one full time Town Clerk effective September 23, 2022.
- 8. Waiver of the requirement for a new special use permit to operate a bar known as The Willow on property located at 428 Manitou Road, and furthermore, consideration of a request to waive the 30-day notification and comment period on an application to the New York State Liquor Authority for a liquor license, requested by Willow Hilton, LLC.
