Authorization to execute intermunicipal agreements with the County of Monroe for receipt and use of New York State Funding for the 2024 Stop DWI Enhanced Enforcement program, in the amount of \$15,982.00 and the High Visibility Engagement Campaign Grant, in the amount of \$5,000.00, and to accept any additional funds which may become available from the New York State STOP-DWI Foundation, Inc. for the period of October 1, 2023, through September 20, 2024
2. Authorization to renew the lease agreement for a five-year term with Monroe County for the lease of data rack space at Building 400, 400 Freight Building Rd., on the property of the Rochester International Airport. This is the first renewal of a possible (3) five-year terms. Further authorization for the Supervisor to execute said agreement.
